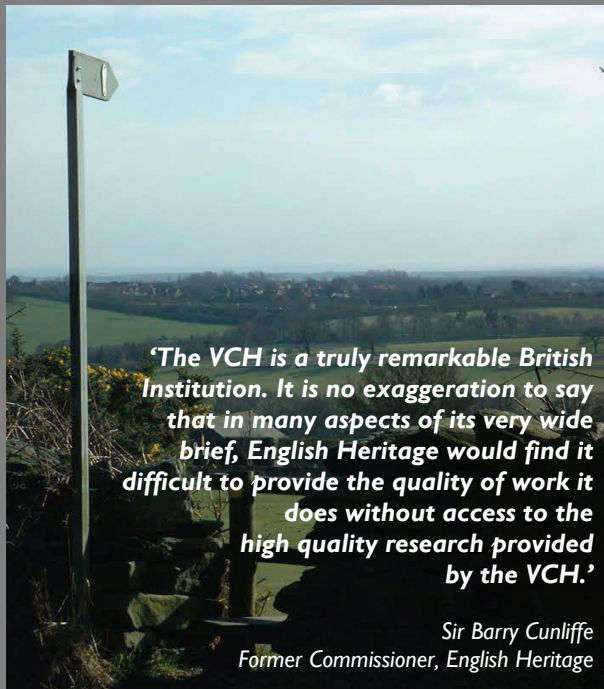

200 Club Rules

The Leicestershire Victoria County History Trust 200 Club, hereafter referred to as 'the Club' has been issued with a Small Society Lottery Licence by Leicester City Council and the Club will be run in accordance with the Small Societies Lottery legislation as specified in the Gambling Act 2005.

The object of the club is to raise funds for Leicestershire Victoria County History Trust ('the Trust', registered company No. 6683052 and registered charity No. 1128575). Of the gross funds available each quarter, 40% will be given as prize money with the balance going to the Trust.

The Club will be managed by a committee consisting of three Friends of the Trust, one of whom will be the promoter. The promoter of the Club is Dr David Holmes, 18 Main St, Kibworth Harcourt, Leicestershire LE8 0NQ. A separate bank account has been opened for administration of the Club's money.

Participants must be over the age of 16. Annual subscriptions to the Club will be £50 payable by cheque or standing order. Payment may also be made by quarterly standing orders of £12.50. Each subscription will be issued with a unique number.

The club will be run on an annual basis but membership may be taken out at any time. An annual subscription payment will be entered into the next four draws following receipt thereof. Each quarterly subscription will be entered into the next draw.

Draws will take place quarterly and there will be first, second and third cash prizes. Draws will take place in March, June, September and December.

The first draw will be made in the quarter when 50 subscriptions have been received. In the event that an initial minimum of fifty subscriptions is not achieved by 31 December 2014 all monies will be returned to participants.

The first prize will be half of the allotted prize money for that quarter, second prize will be a third and third prize will be one sixth. Prize winners will be notified in writing or by email and payment will be made by cheque and sent by mail to the address specified by the winner. In the case of any disagreement, the decision of the committee will be final.

The winning numbers for each draw will be published and if they consent, the names of the winners. Details as agreed by the winners will be available for inspection at the Trust's headquarters, published in its newsletters and posted on its website.
